- 2. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders, Hyderabad, the Partnership Firm M/s Ravitej Projects, (Firm No. 234 of 2015), is registered as Special Class (Civil) contractor, who is qualified to tender for works costing up to any amount.
- 3. The Firm with Partners mentioned at Para-1 above which is now registered as Special Class (Civil) Contractor shall intimate any changes in the Partners/Name of the firm in the partnership deed, if any, to the registering authority within one month of such change for taking action as per rules in force. Failure to notify the changes will entail the firm to forfeit Contractor Registration and further the firm will be debarred from tendering for works.
- 4. The Managing Partners / Partners of the firm mentioned at Para-1 above should not hold Contractor Registration in their Individual names or as a Proprietor / Partner / Managing Partner/ Director / Managing Director of any other Firm / Company anywhere in Telangana State. Further the Firm also furnished an undertaking Signed by all partners accordingly. Therefore the violation of the condition will entail forfeiture of Contractor Registration and action shall be initiated as per rules.

- 5. The proceeding is valid with effect from Dt: 24.02.2020 and the validity of registration of the Partnership firm M/s Ravitej Projects, (Firm No. 234 of 2015), will be up to Dt:23 .02.2025 only i.e., 5 years from the date of issuance. The registering authority reserves the right to cancel or demote the registration without notice and without assigning any reasons.
- 6. Application for renewal of Registration beyond Dt: 23 .02.2025, if desired, should be submitted to this office before one month from the date of expiry of validity of registration.
- 7. The certificates produced by the Partnership Firm, which is now registered as Special Class (Civil) Contractor shall be genuine and correct and if any discrepancy is found later on, the existing Registration under this category stands cancelled.
- 8. The Partnership Firm registered in Special Class (Civil) can also tender for the works falling under lower classes.
- 9. All the other existing Contractor registrations if any in the State of Telangana with same specialization in different classes in the name of the Proprietor / Individual and in the name of the Managing Director / Managing Partner / Director / Partner of any Company / Firm stands cancelled.
- 10. If the firm uses the old registration proceeding after getting the new registration proceeding it is liable for disciplinary action.
- 11. All the assets, liabilities including obligations, ongoing works entrusted, receiving of bills pending from various departments and experience gained etc., in the name of M/s Ravitej Projects, (Firm No. 234 of 2015), shall stand transferred in the name of the firm M/s Ravitej Projects, (Firm No. 234 of 2015).
- 12. All the Partners including Managing Partner of the firm M/s Ravitej Projects, (Firm No. 234 of 2015), shall be responsible and personally discharge all the liabilities, due to the departments that arise out at any time in future from the works done by M/s Ravitej Projects, (Firm No. 234 of 2015), prior to issue of the proceedings.
- 13. The firm which is now registered as Special Class (Civil) Contractor shall attend this office along with three passport size color photographs for the purpose of obtaining identity card from this office within ten days from the date of issue of proceedings. The identity card issued along with the original registration certificate shall invariably be presented at the time of submission of Tenders.
